## **TOWN COUNCIL MEETING THURSDAY, NOVEMBER 4, 2021 6:00 PM**

Vice President Jackey Apache called the meeting to order with members Richard (Rick) Hadley, Doyle Allison, and Daniel Klumpe present. President Amy Brown was absent.

The council held the hearing on utility disconnection for non-payment. No one was present to discuss their situation. Rick Hadley made the motion to approve those listed on the shutoff list be shutoff. Doyle Allison seconded the motion, and all were in favor.

BF&S Engineer Dave Buck explained that Pavement Solutions did get the Cape Sealing done but did not get the Crack Sealing done. There is another product other than what was specified in the bid packet that would work in the winter however the roads would be bumpier until it warms-up and traffic flattens it some. His recommendation would be to allow them an extension of time until the spring and use the material that was specified in the bid packet. The Council talked that they would be ok with waiting if INDOT is ok with the town not utilizing the grant funds until the spring. They also would want assurances that our project would be finished by a certain date in the spring. Clerk-Treasurer Treeva Sarles will talk with INDOT about the grant and Dave will get with the contractor on assurances of a new deadline.

The Council considered Ordinance 2021-1104A Amending the 2021 salary ordinance to include the part-time labor position, the full-time maintenance operator position and for the operators holding a provisional license. Rick Hadley made the motion to adopt Ordinance 2021-1104A. Doyle Allison seconded the motion, and all were in favor.

Jackey Apache read the summary of claims presented for a total of \$183,098.16. Rick Hadley made the motion to approve the claims as presented. Daniel Klumpe seconded the motion, and all were in favor. Daniel Klumpe made the motion to approve the October 2021 Minutes as written. Rick Hadley seconded the motion, and all were in favor.

Town Administrator Ron Shoup announced he hired James Crain for the full-time Maintenance operator position. The Town employees continue to pick up limbs, it's been slow because of so much and being short staffed.

Now that we have a full-time Maintenance Operator, he hopes we can have this finished in 2 weeks.

Clerk-Treasurer Treeva Sarles brought up handbook revisions for discussion. The Council discussed Paid Time Off. Other changes were adding the town now provides health insurance and contributes to the employee's health savings account. She will make the changes and bring back for adoption. She brought up that Benton County Recycling has ordered the recycle trailer and it should be here in January. Treeva had prepared a list of items for year-end to purchase with some remaining budget. These included \$6,125 for new computers; \$10,000 to enhance security, the consultant budget needs to be increased by \$7,375; and \$4,500 to purchase new shirts and winter gear for employees. The Council unanimously agreed to move forward on the computers and uniforms and winter gear; to increase the consultant budget and to get quotes on security enhancements. She brought up the email from the attorney about purchasing the lot at US52 and Main Street. He had heard from the realtor they would consider \$28,000. The Council discussed at length. Daniel Klumpe made the motion to offer \$26,000 and pay half of closing costs. Rick Hadley seconded the motion. Daniel Klumpe, Rick Hadley and Jackey Apache were in favor. Doyle Allison voted against it. The motion carried. Lastly, she brought up the amount of money per hour we are paying Tim Clark on the Building Permitting items. We still need to have someone get this figured out and we really need to have a designated employee to handle this. The council discussed a new position to be the Deputy Town Administrator that would handle this as well as other duties. Ron and Treeva will put together a job description and report back to the Council.

With nothing else to come before the Council, Rick Hadley made the motion to adjourn at 7:58 PM. Doyle Allison seconded the motion, and all were in favor.

**SPECIAL MEETING OF THE  
OTTERBEIN TOWN COUNCIL  
THURSDAY, November 11, 2021 4:30 PM**

Council President Amy Brown called the meeting to order at 4:30 PM with members Jackey Apache, Richard (Rick) Hadley and Daniel Klumpe present. Member Doyle Allison was absent.

The Council open and read aloud the sealed bids for Municipal Solid Waste Disposal. Bids received for a 3-year contract were Trash Kans LLC for \$318,240.00 and Waste Management of Indiana LLC for \$313,809.60. The bids appeared to be in order. Rick Hadley made the motion to enter into contract with Waste Management for a 3-year contract for a total of \$313,809.60. Daniel Klumpe seconded the motion, and all were in favor.

Treeva brought up the recycle bins for residents to take recycling to the recycle trailer. The other towns do not provide them. The cost per bin is \$11.20. The council unanimously agreed to not provide bins at this time.

The council discussed the job description and advertisement for the newly created position of Deputy Town Administrator. They discussed a range for salary of \$19.00 - \$22.00 per hour. They asked Treeva to proceed with advertising this position.

With nothing else to come before the Council, Jackey Apache made the motion to adjourn at 5:00 PM. Daniel Klumpe seconded the motion, and all were in favor.

Ordinance 2021-1118A and Ordinance 2021-1118B were read. There were no public present to make comments or ask questions. There were no additional questions or comments from the Town Council.

Amy Brown called the meeting to order at 6:19 PM will all members present.

Colin Sullivan with BF&S Engineering presented a letter regarding the maintenance plan for the Dirk Studebaker Trail as part of the application process for the grant. Daniel Klumpe made the motion that Amy Brown sign the maintenance plan letter. Rick Hadley seconded the motion, and all were in favor. He presented a letter of support from the Council for the said trail and application of the grant. Daniel Klumpe made the motion for Amy Brown to sign the support letter. Jackey Apache seconded the motion, and all were in favor. Lastly, he presented a letter that states, if the town can not obtain easement for the trail, they would consider using eminent domain to obtain the easement. Daniel Klumpe made the motion, the Council would consider it, and for Amy to sign the letter. Jackey Apache seconded the motion, and all were in favor.

Town Administrator Ron Shoup requested to purchase a snow blower from Riggs in Lafayette for a not to exceed \$1,300. Jackey Apache made the motion to purchase the snow blower for a not to exceed \$1,300. Rick Hadley seconded the motion, and all were in favor.

Clerk-Treasurer Treeva Sarles asked the Council if they wanted the Town to host a Coloring Contest this year and if so, what is the budget. Amy Brown made the motion to host the coloring contest with a budget of \$200. Daniel Klumpe seconded the motion, and all were in favor. She asked Council if they were going to do something for the employees this year for Christmas. The Council would like to hold a Christmas Party at the Community Center.

Amy Brown read the summary of claims presented for a total of \$78,513.67. Jackey Apache made the motion to approve the claims as presented. Daniel Klumpe seconded the motion, and all were in favor.

The Council considered Ordinance 2021-1118A An Ordinance to amend Title V, Chapter 53, Section 53.01 (A) and Title I, Chapter 10 Section 10.98 (K) of the Code of Ordinances of the Town of Otterbein to adjust Water Rates. Rick Hadley made the motion to adopt Ordinance 2021-1118A. Jackey Apache seconded the motion, and all were in favor. The Council considered Ordinance 2021-1118B an Ordinance to Amend Title V Chapter 51, Section 51.140 (C) and (E) (1) of the Code of Ordinances of the Town of Otterbein to adjust Wastewater Rates and Charges. Daniel Klumpe made the motion to adopt Ordinance 2021-1118B. Doyle Allison seconded the motion, and all were in favor. The Council considered Ordinance 2021-1118C An Ordinance to amend Title V, Chapter 50, Section 50.01 Title V, Chapter 54 Section 54.01 and 54.05 and Title I, Chapter 10, Section 10.98 (D) of the code of Ordinances of the Town of Otterbein to amend the fixed monthly Stormwater Management Fee Pursuant to I.C. 8-1.5-5-7. Rick Hadley made the motion to adopt Ordinance 2021-1118C. Jackey Apache seconded the motion. Rick Hadley, Jackey Apache, Amy Brown and Doyle Allison were in favor. Member Daniel Klumpe was opposed. Motion carried.
